ARTICLES OF INCORPORATION
OF

ARTICLES I - NAME

The name of the corporation shall be Keys Medical Transport, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transporting medical patients from one Hospital to another and for all other purposes as allowed under County, State and Federal laws.

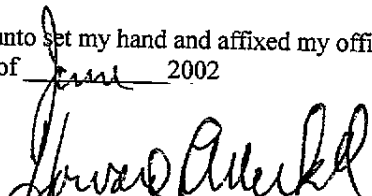
