ARTICLE XI. By Laws. The power to adopt, alter, amend or re-peal by-laws shall be vested in the Board of Directors and the shareholders.



ARTICLES XV. The corporation shall be effective upon acceptance by the state of Florida of these articles.



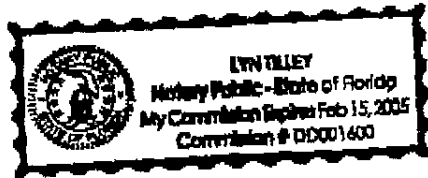


