ARTICLES - NAME

The name of this Corporation is Bluewater Pools, Inc.

ARTICLE III - PURPOSE

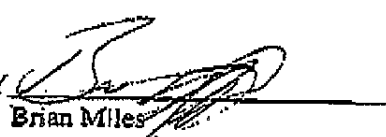
