ARTICLES OF INCORPORATION OF REVENUE MANAGEMENT SOLUTIONS, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is REVENUE MANAGEMENT SOLUTIONS, INC. and its principal office and mailing address is 220 S. Franklin Street, Tampa, FL 33602

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State.
