ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation of the above-named professional service corporation, filed with the Department of State on June 20, 2002, Charter #P02000067828, as follows:

1. Article I on page 1 of the Articles of Incorporation of the above-named corporation is hereby revoked in its entirety and the following is substituted in its place:

"ARTICLE I

*The name of this corporation is YOUNG TRUCKING BROKERAGE, INC.  
Its principal place of business and mailing address is 12164 Tamiami Trail, Punta  
Gorda, Florida 33955."*


