**ARTICLES OF INCORPORATION  
OF  
MIKERO, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is MIKERO, INC.

**ARTICLE II**

The existence of the Corporation shall begin on June 5, 2002.

**ARTICLE III**

The steet address of the principal office of the Corporation is 7745 S.W. 86<sup>th</sup> Street, Apt. D319, Miami, Florida 33143.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 


The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.
