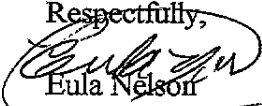

ARTICLE 1 - NAME

The name of the corporation shall be: **The Trading Depot, Inc.**

ARTICLE 2 - PRINCIPAL OFFICE

ARTICLE 3 - PURPOSE

The purpose for which the corporation is organized: **Importing and exporting Agency.**

ARTICLE 4- SHARES

The corporation is authorized to issue **5000 shares** of common stock at no par value.

ARTICLE 7 - OFFICERS

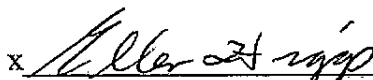
