ROG & ASSOCIATES, INC.**

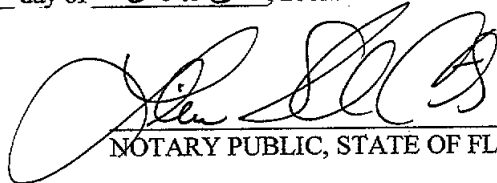

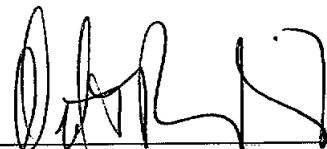
