Name

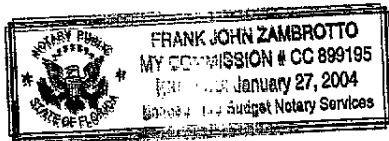


