The name of the corporation shall be Eland Ventures Inc.

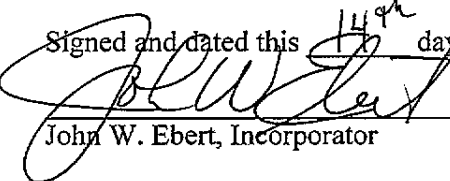

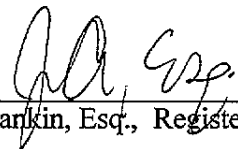
ARTICLE VII -INDEMNIFICATION:
