## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BULK LINES, INC. NOW KNOWN AS LARRY YOUNG, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation of the above-named professional service corporation, filed with the Department of State on June 20, 2002, Charter #P02000068356, as follows:

1. Article I on page 1 of the Articles of incorporation of the above-named corporation is hereby revoked in its entirety and the following is substituted in its place:

## "ARTICLE I

The name of this corporation is LARRY YOUNG, INC. Its principal place of business and mailing address is 12164 Tamlami Trail, Punta Gorda, Florida 33955."

The foregoing Amendment was adopted by the unanimous affirmative vote of the shareholders on December 2018 to be effective upon the filing of these Articles of Amendment with the Florida Department of State. - 3. The right to amend or revoke the foregoing Articles of Amendment to the Articles of Incorporation of the said corporation in whole or in part is hereby reserved.
- 4. In every other respect, I hereby confirm and republish the said Articles of Incorporation of BULK LINES, INC. n/k/a LARRY YOUNG, INC. as filed with the Department of State on June 20, 2002:
