ARTICLES OF INCORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation of the above-named professional service corporation, filed with the Department of State on June 20, 2002, Charter #P02000068356, as follows:

1. Article I on page 1 of the Articles of Incorporation of the above-named corporation is hereby revoked in its entirety and the following is substituted in its place:

"ARTICLE I

*The name of this corporation is LARRY YOUNG, INC. Its principal place of business and mailing address is 12164 Tauriani Trail, Punta Gorda, Florida 33955."*

2. The foregoing Amendment was adopted by the unanimous affirmative vote of the shareholders on December 27, 2018 to be effective upon the filing of these Articles of Amendment with the Florida Department of State. The number of votes cast for the Amendment by the shareholders was sufficient for approval.

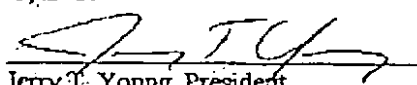
3. The right to amend or revoke the foregoing Articles of Amendment to the Articles of Incorporation of the said corporation in whole or in part is hereby reserved.
