ARTICLES OF INCORPORATION

OF

523-CASH NOW INC.

I, the undersigned, hereby form, organize and incorporate under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLE I.

The name of the corporation shall be 523-CASH NOW INC.

ARTICLE II.

The general nature of the business and the objects and purposes are to engage in all legal purposes permitted by law.

SECTION 1. This corporation may engage in any activity or business permitted under the laws of the State of Florida, and shall enjoy all the rights and privileges of a corporation granted by the laws of the State of Florida.

SECTION 2. To purchase, to receive by way of gift, subscribe for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle onconsignment, own, hold for investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, contract in respect of, guarantee, trade and sell, exchange, deal in, let, lend, export, mortgage,

pledge, deed in trust, hypothecate, encumber, transfer, assign and in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal or mixed, tangible or intangible, wherever situated and however held, including but not limited to, warrants, script, certificates, debentures, mortgages, notes, commercial paper and obligations and evidence of interests in or indebtedness of any corporation, foreign or domestic, firm or or any government of subdivision or agency thereof, documents of title, accompanying rights, and every other kind and character personal property, real property (improved and unimproved), and the products and avails thereof, and every character of interest therein and appurtenances thereto, including, but not limited mineral, oil, gas and water rights, all or any part of any ongoing business and its incidents, franchises, subsidiaries charters, concessions, grants, rights, powers or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all οf the rights, powers, privileges, and immunities of individual owners or holders thereof.

SECTION 4. To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations.

To let concession to others to do any of the things that this corporation is empowered to do, and to enter into, perform and carry out, contracts and arrangements of every make. kind and character with any person, firm, association corporation. or any government orauthority or subdivision agency thereof.

SECTION 6. To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any the foregoing purposes or otherwise, orthat it may calculated. directly or indirectly, to improve the interests this corporation, and to do all things specified in Florida Statute 607, and to have and to exercise all powers conferred by the laws ο£ the State of Florida on corporations formed under the law pursuant to which and under which this corporation is formed, such laws are now in effect or may at any time hereafter amended, and to do any and all things hereinabove set forth to the

same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations or corporations, and in any part of the world.

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares have no par value.

The amount of capital with which this corporation shall begin business will not be less than Five Hundred (\$500.00) Dollars.

ARTICLE V.

The corporation is to have perpetual existence.

ARTICLE VI.

The principal place of business of the corporation shall be 1337 NORTH EAST 12TH AVENUE, FORT LAUDERDALE, FLORIDA, 33304 or any other city in the State of Florida designated by the Board of Directors.

ARTICLE VII.

This corporation shall have TWO (2) director(s) initially. The number of directors may be increased from time to time by the By-Laws adopted by the stockholders, but shall never be decreased to less than one (1).

ARTICLE XI.

The executive officers of this corporation may be a President, a Vice President, a Secretary and a Treasurer. Any person may hold two or more offices. The corporation may also have such other officers and agents as may be deemed necessary and all such officers and agents shall be chosen in such manner, take and hold

their offices for such terms, and have such powers and duties as may be prescribed by the By-Laws, or determined by the Board of Directors.

ARTICLE XII.

The private property of the stockholders of the corporation shall not be subject to the payment of the corporation's debts to any extent whatever.

Every director and officer shall be indemnified against civil and criminal, incurred in relation hìs duties, including all reasonable expenses of defense, except to the extent that he shall have been finally adjudged to be liable negligence or misconduct in the matter out of which the liability arises.

ARTICLE XIII.

- (b) To determine and fix the value of any property to be acquired by the corporation and to issue and to pay in exchange therefor, stock of the corporation; and the judgment of the directors in determining such value shall be conclusive.

To set apart out of any funds of the corporation available for dividends, reserve or reserves for working capital or for any other lawful purposes, and also to abolish any such reserve in the same manner in which it was created.

(d) To determine from time to time whether and to what extent, and to what times and places, and under what conditions and regulations the accounts and books of the corporation, or any of the books, shall be open for inspection by the stockholders, and no

stockholder shall have any right to inspect any account or book or document of the corporation except as conferred by the laws of the State of Florida, unless and until authorized to do so by resolution of the Board of Directors or of the stockholders.

(e) The Board of Directors may, by resolution, provide for the issuance of stock certificates to replace lost or destroyed certificates.

ARTICLE XIV.

If the By-Laws so provide, the stockholders and the Board of Directors of the corporation shall have the power to hold their meetings, to have an office or offices, and to keep the books of the corporation, subject to the provisions of the laws of the State of Florida, outside of said state at such place or places as may be designated from time to time by the Board of Directors.

The corporation may, in its By-laws, confer powers upon the Board of Directors in addition to those granted by this Certificate of Incorporation, and in addition to the powers and authority expressly conferred upon them by the laws of the State of Florida.

Election of Directors need not be by ballot unless the By-Laws so provide.

Directors shall be entitled to reasonable fees for their attendance at meetings of the Board of Directors.

ARTICLE XV.




