The name of this corporation is LA NUEVA VALLARTA, CORP.

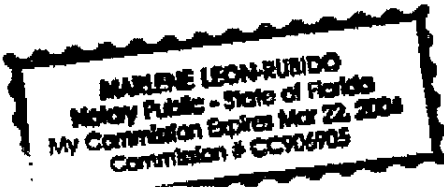




