The name of this Corporation shall be as follows: SECRETARY OF STATE

ARTICLE II

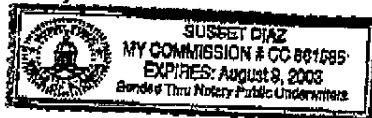
