#### ARTICLES OF INCORPORATION

#### ARTICLE ONE

The name of this corporation is B.M.P. Records, Inc. and the mailing address of the corporation shall be 1517 Huntdale Street, Lehigh, FL 33936.

# ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

#### ARTICLE THREE

The duration of the corporation is perpetual.

#### ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of producing and distributing music recordings and other related entertainment services.
- 2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
