It is with great dismay that on October 14, 2003, we received from the Division of Corporations a Certificate of Administrative Dissolution for GBG Legal Services, P.A., allegedly for failure to timely file our 2003 corporation annual report/uniform business report. The corporation was administratively dissolved or revoked on September 19, 2003. We immediately contacted your office by telephone to inform you that we had indeed timely filed our UBR and paid the proper filing fee. We were told by a Mr. Ladell of your office to send you a letter to clear up this matter after we had had a chance to contact our bank concerning the Department of State's cashing of the filing fee that we had timely remitted.

As the attached evidence indicates, the dissolution or revocation was done in error since GBG Legal Services, P.A. did indeed timely file its 2003 For Profit Uniform Business Report (UBR) on April 23, 2003 via overnight (express) mail and properly paid the \$150.00 filing fee via our office check number 1038. Note that at the same time we filed the UBR for GBG Legal Services, P.A, we also timely filed the UBR for our other corporation, Gillett Business Services, Inc., a corporation in good standing (UBR Document Number P02000122274 – See Exhibit H). Enclosed at Exhibit A are copies of the front and back of our check number 1007 for \$150.00 representing payment of the annual filing fee for Gillett Business Services, Inc., and said check was cashed by the Department of State. That check and the UBR for Gillett Business Services, Inc. were in the same overnight (express) mail envelope that the UBR and filing fee for GBG Legal Services, P.A. were in. Each UBR and corresponding check were in their own, separate envelope and each envelope was sealed. Both sealed envelopes were inside the overnight (express) mail package sent to the Department of State.

Attached at Exhibit B is a copy of the filed 2003 UBR for GBG Legal Services, P.A. Exhibit C contains a copy of the U.S. Postal Service's overnight (express) mail receipt number ER 060641430 US showing that the UBRs and checks were mailed to the Division of Corporations on April 23, 2003 and at Exhibit D is a copy of the confirmation sheet form the U.S. Postal Service evidencing that a Mr. Ricky D. Cotton signed for, and accepted delivery of, our package to the Division of Corporations on April 24, 2003 at 10:14 am.

At Exhibit E are two items: 1) a copy of the Bank of America Transaction Slip for the \$150.00 payment that, according to Mr. Antar Abraham of Bank of America, may have been electronically cashed by the Department of State in lieu of presentation of check number 1038 that we remitted and 2) a copy of the letter from Mr. Antar transmitting the Transaction slip to us. At Exhibit F is our application for Reinstatement of GBG Legal Services, P.A.

Please note that, as shown at Exhibit G, on July 3, 2003 we received a UBR that had to be filed by September 10, 2003 if one had not been previously filed. The notice clearly states: "You may disregard this notice if the 2003 uniform business report has been filed." Nonetheless, we promptly called your office at 850-245-6051 and spoke with Agnes who told us to disregard this notice since it may have crossed in the mail with our UBR. Note also that the notice itself states: "The Division does not mail out any form of acknowledgement of the filing of the uniform business report unless a certificate of status is requested and paid for."

Given that GBG Legal Services, P.A. did comply with its obligation to timely file its 2003 UBR and it timely paid the \$150.00 filing fee, we respectfully request that you immediately and retroactively reinstate the corporation and that your records reflect that the corporation was administratively dissolved or revoked in error and through no fault of GBG Legal Services, P.A.

Your immediate attention to this grave matter would be greatly appreciated.
