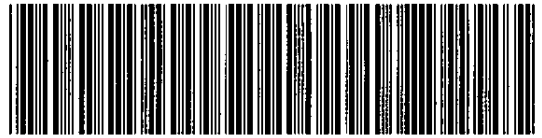

The name of this corporation is IMG PHYSICIANS SERVICES, INC.

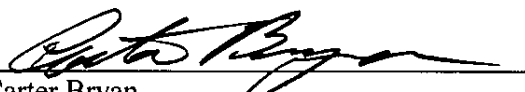
ARTICLE II

ARTICLE III

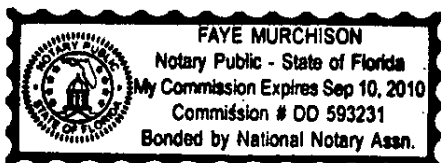
On July 9, 2009, the shareholders of this corporation elected and authorized that the corporation be dissolved. The number of votes cast was sufficient for approval.
