THE UNDERSIGNED subscriber to these articles of incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. ARTICLE I – Name


ARTICLE X - Amendment
