ARTICLES OF INCORPORATION OF MANUCY MANAGEMENT, INC.



ARTICLE I NAME AND ADDRESS:

The name of the corporation is Manucy Management, Inc. and its address is 3 Court Theophelia, St. Augustine, Florida 32084.

ARTICLE II DURATION:

This Corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles.
