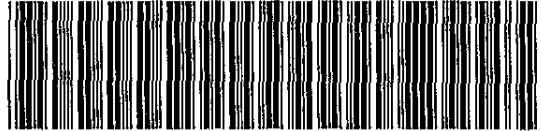

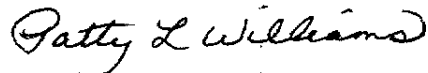

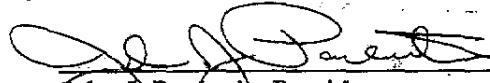
**FIRST:** ARTICLE I I is amended to state that the principal place of business and mailing address of the corporation shall be:

**THIRD:** This Amendment shall be effective immediately upon filing with the Department of State of Florida.

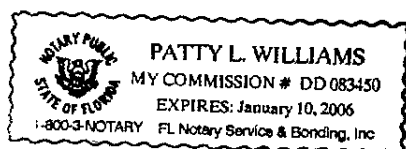

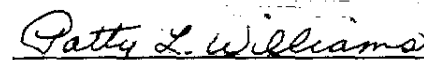

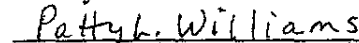
