In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation of the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is KATHY BRADLEY PAINTING, INC.

ARTICLE II




The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
