ARTICLES OF INCORPORATION

OF

ELIZABETH FORT INTERIORS, INC.



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Elizabeth Fort Interiors, Inc.

ARTICLE II

The existence of the Corporation shall begin upon filing.

ARTICLE III

The street address of the principal office of the Corporation is 1300 Corporate Center Way, Suite 105B, Wellington, FL 33414.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares.
