The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional association under the laws of the State of Florida.

ARTICLE I - NAME OF PROFESSIONAL ASSOCIATION

The name of this professional association shall be RON WOODCOCK, P.A.

ARTICLE II - DURATION

This professional association shall exist perpetually.

ARTICLE III - INITIAL PRINCIPAL OFFICE

The initial principal office of the professional association shall be located at 954 South Orlando Avenue, Winter Park, FL 32789.

ARTICLE IV - PURPOSE

This professional association is organized for the purpose of transacting real estate business.

ARTICLE V - CAPITAL STOCK

A. The maximum number of shares of capital stock that this professional association is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, which may be fractional shares.

B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued shall become and be fully paid and non-assessable, the

same as though paid for in cash; and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.

C. Notwithstanding the foregoing, the professional association shall have the right to increase its capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers, of such additional stock, in an amendment to its Certificate of Incorporation.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this professional association shall be 954 South Orlando Avenue, Winter Park, FL 32789.

The name of the initial registered agent of this professional association at that address shall be Ron Woodcock.

ARTICLE VII - INITIAL DIRECTORS AND OFFICERS




