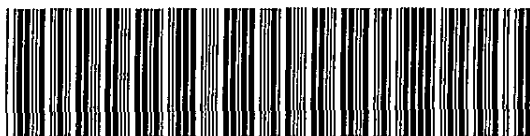

ARTICLE I - NAME


The name of this corporation is BRAUTIGAM & ASSOCIATES, INC.
