**ARTICLES OF INCORPORATION
OF**

TRADE COACH INTERNATIONAL, INC.

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be Trade Coach International, Inc.
The address of the principal office of the corporation and the mailing address of the corporation is 740 East Cumberland Street, Jacksonville, Florida 32259.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The general purpose for which the corporation is organized shall be any lawful business, for profit, for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 50,000,000 shares of non-assessable common stock, each share having a par value of \$.0001, which may be issued for such consideration having a value of not

less than the par value of the shares issued therefor as to the board of directors shall be deemed appropriate.

ARTICLE V

The street address of the corporation's initial registered office is 740 East Cumberland Street, Jacksonville, Florida 32259, and the name of its initial registered agent at that office is Ann Leheta. A written acceptance as required in §607.0501(3), Florida Statutes, is attached hereto and made a part hereof.

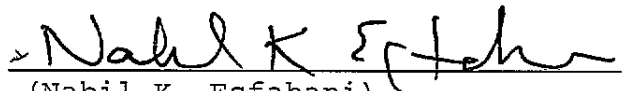

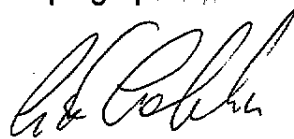
