ARTICLES OF INCORPORATION OF GREAT ART FOR REAL PEOPLE GALLERY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation shall be:
