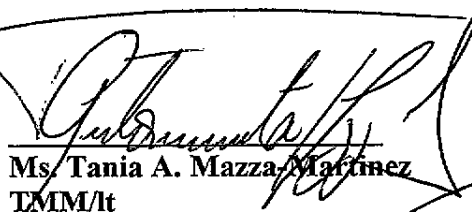

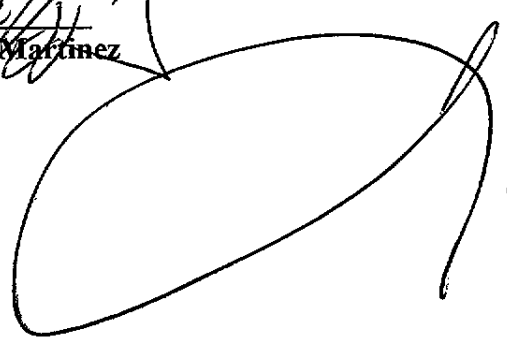

ARTICLE I - NAME

The name of this corporation INTERMODAL INATLAN SERVICES, INC.

ARTICLE IX- INDEMNIFICATION

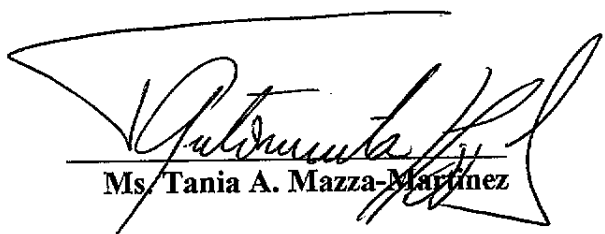
The corporation shall indemnify any officer or Director, or any former Officer or Director, to the full extent permitted by law.

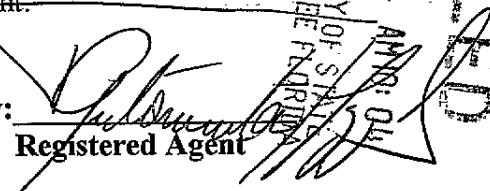
