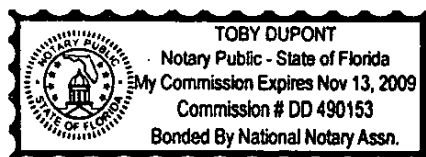
1. Dawn D. Scandale is the President of BAMBOOZ, INC., a Florida corporation, (hereinafter "Corporation").
