Enclosed is the 2007 Annual Report for Robert L Manley CPA, PA and an accompanying check in the amount of \$150.00.

I am embarrassed and very sorry that I did not submit the report on a timely basis. I certainly had every intention of filing and paying on time. In fact, I had already downloaded and printed the enclosed report well before May 1, 2007, but in the rush of closing out the tax season, I failed to submit the report by the deadline.

There was one particularly extenuating circumstance that may have contributed to my mental lapse, and that is the fact that an elderly brother of one of my clients died during the tax season, and as soon as the 4/17/07 filing deadline had passed, I became very involved in handling the tax aspects of this case, including gathering information to file income tax returns that had not been filed for several prior years.

In view of the potential late-filing penalty of \$400, I'm sure that you can understand that I am most hopeful that you can accept my \$150 payment and waive the penalty--which penalty I honestly can ill-afford to pay, as I am a sole-practitioner with a relatively small, part-time CPA practice which produces only modest income.

Any consideration that you can give to this waiver request will be most gratefully appreciated. And, I will do my best to file on a timely basis in the future.
