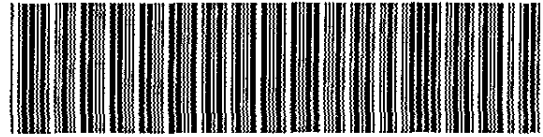




ARTICLE VI - ADOPTION OF DISSOLUTION

On November 6, 2002, at a duly constituted meeting, the dissolution was approved by all the shareholders and by all the directors of this Corporation.


ARTICLE VII - EFFECTIVE DATE
