ARTICLE I-Name

The name of this corporation is Turn One, Inc.

ARTICLE II- Principal Office

The address of the principal office is 12 Triangle Park Plaza, Lake Placid, Florida 33852 and the mailing address is Post Office Box 487, Lake Placid, Florida 33862.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock

This corporation is authorized to issue Eight Thousand (8,000) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

ARTICLE XI-Amendment

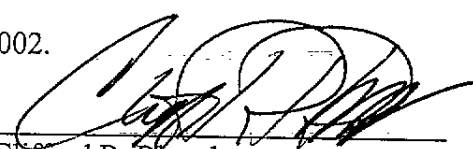

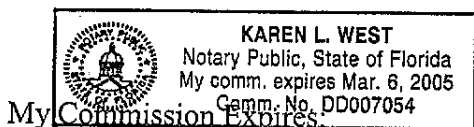
