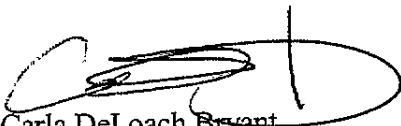

The total number of shares of stock which the professional association shall be authorized to issue or have outstanding at any one time is 100 shares.

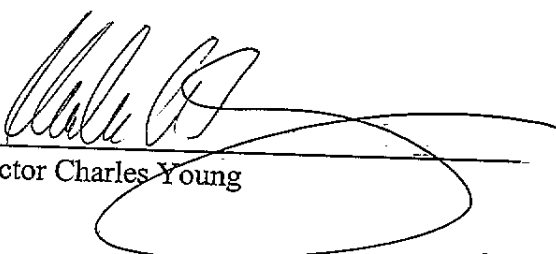

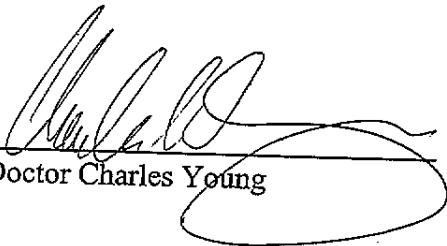
