ARTICLES OF INCORPORATION
OF
CARPET & TILE DIRECT OF SARASOTA, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is CARPET & TILE DIRECT OF SARASOTA, INC.

ARTICLE II

- A. This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
- B. The general nature of this business to be transacted by this corporation is: to engage in any and all wholesale and retail sales of carpet and tile in the State of Florida.

ARTICLE III

The aggregate number of shares of stock which the corporation shall have the authority to issue is Five Hundred (500) shares of Common Stock with a par value of One Dollar (\$1.00) per share.
