The undersigned Incorporator of these Articles of Incorporation, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

### ARTICLE I

# NAME

The name of the corporation is YOUR EYES & EARS, INC.

# ARTICLE II

### **ADDRESS**

The principal place of business and mailing address of the corporation is 2338 Immokalee Road, #113, Naples, Florida 34110.

## ARTICLE III

## **DURATION**

This corporation shall commence its existence on the date of filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

#### ARTICLE IV

## **PURPOSE**

any meeting of the Board of Directors of this Corporation which shall authorize any such contract or transaction.
