Article III – Purpose

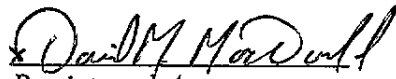
*The general purposes for which the corporation is organized are:

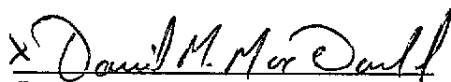
Article V – Registered Agent
