ARTICLES OF INCORPORATION OF

ARTICLE 6 - CORPORATE CAPITALIZATION

- . 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is 1,000 Shares of common stock, each share having the par value of 1.00.

ARTICLE 10 - TITLE


