**ARTICLES OF INCORPORATION  
OF  
LMS DEVELOPMENT, INC.**

**THE UNDERSIGNED**, acting as sole incorporator of LMS DEVELOPMENT, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME**

The name of the corporation is LMS DEVELOPMENT, INC.

**INITIAL BOARD OF DIRECTORS**




