**ARTICLE I
CORPORATE NAME**

The name of this corporation shall be:

PRACTICE PAY SOLUTIONS.COM, INC.

**ARTICLE II
DURATION**

This corporation shall commence its existence upon the filing of these Articles of Incorporation, and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III




