ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **GLIVA SERVICES, INC.**

ARTICLE II: NATURE OF BUSINESS

The Corporation will mainly provide Janitorial and Cleaning Services, but may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is one thousand (1,000) shares, of one dollar (\$1.00) par value per share.

ARTICLE IV: INITIAL CAPITAL

The amount capital with which this corporation will begin business will not be less than one thousand dollars (\$1000.00).

ARTICLE V: TERM OF EXISTENCE

The Corporation is to have perpetual existence.
