**ARTICLE I - NAME AND MAILING ADDRESS**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

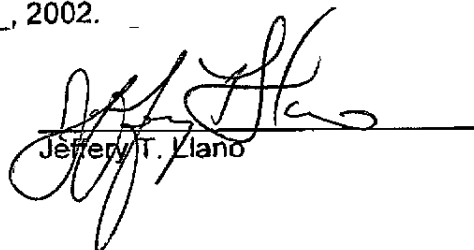
**ARTICLE VIII - INDEMNIFICATION**
