# Articles of Incorporation For

## ARTICLE I - NAME

The name of this Corporation is Guis Enterprises, Inc..

### ARTICLE II - DURATION

This Corporation shall have a perpetual existence commencing upon the filing of these articles.

# ARTICLE III - PURPOSE
