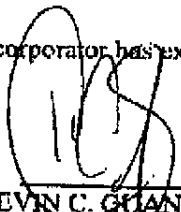
Article VIII

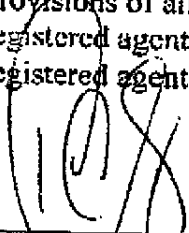
