The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS: The name of the corporation is **Catheterization Services of Sarasota, Inc.**, and its mailing address is 1540 South Tamiami Trail, Sarasota, Florida 34239.

DURATION: The corporation shall exist perpetually.



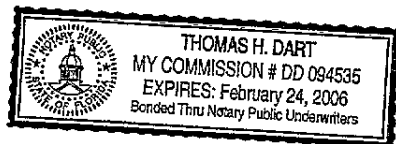


