ARTICLES OF INCORPORATION OF ZAM ZAM GENERAL TRANSPORT, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State

1. ARTICLE I Name.

The name of the corporation shall be:

2. ARTICLE II PRINCIPAL OFFICE
