In October, you were informed in order to avoid confusion with the E-911 Emergency System it is necessary to readdress all properties on Duncan Court. The new address for Parcel ID 06-21-29-507-0000-0470 is:

This street address has been reassigned in accordance with Seminole County Ordinance 00-22. You have thirty (30) days from receipt of this notice to post this number in a manner which complies with this Ordinance (posting of numbers information enclosed). Failure to do so shall result in a complaint being filed against you with the Seminole County Code Enforcement Board which has the power to levy fines up to \$250.00 per day.

If you currently have a post office box, this will not change your mailing address. However, if your mailing address does change, to assist in the address transition, the post office will deliver mail to your old address for up to twelve months.

A copy of this letter was sent to your telephone and power company, the Post Office, the Seminole County Property Appraisers Office, Elections Office and the 911 Office who in turn enter the information in the 911 system database which directly relates your new address to Seminole County Public Safety and Sheriff's Department in the event of an emergency call. To maintain uninterrupted service, we urge you to notify the post office, telephone, power, cable and other concerned parties of your change of address within the next few days. Enclosed is a listing of company names and telephone numbers for your convenience.
