ARTICLES OF INCORPORATION

OF

KLD FINANCIAL CONSULTANTS PA

The undersigned, for purposes of forming a professional corporation under the provisions of §607, the Florida Business Corporation Act and §621 the Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE 1

The name of this corporation shall be KLD FINANCIAL CONSULTANTS PA (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the office of the Corporation is 5740 Surrey Circle East, Davie, Florida 33331.

ARTICLE III
