CERTIFICATE OF INCORPORATION

OF

NOBEL PAINT & BODY SHOP CORP.

We, the undersigned incorporator(s), hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of an incorporation for profit.

ARTICLE I

The name of the corporation shall be:

The corporation may engage in any activity or business permitted under the laws of the State of Florida and of The United States of America..

Corporation subject to the provisions of the statute outside the State of Florida at such places as may from time to time be designated by the Board of Directors.


ARTICLE X


