## **ARTICLES OF INCORPORATION**

of

**KENT and LASCEL, of BREVARD, INC.**

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

### **ARTICLE I - NAME**

The name of the corporation shall be **KENT AND LASCEL OF BREVARD, INC.**

### **ARTICLE II - PRINCIPAL OFFICE**

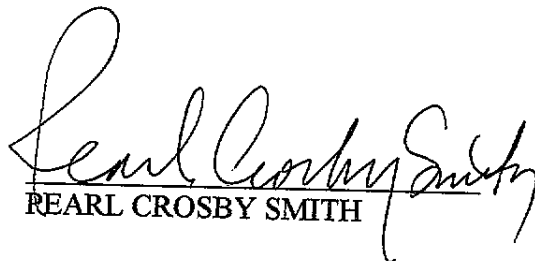
