ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: THE FIVE CAP'S CORP., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 201 West Shell Point Road, Ruskin, Florida 33570.

The principal mailing address of this corporation shall be: 201 West Shell Point Road, Ruskin, Florida 33570.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of flower arrangements and gifts, pack and ship products, agricultural affiliations and minor real estate as it relates to above; and
2. 
ARTICLE VII INCORPORATOR
